### Political Change and the Fortunes of Incumbents

From the 1950s through the 2010s the geographical bases of American political parties shifted dramatically. States once solidly for one party are now voting solidly for the other. This analysis examines how the fortunes of incumbents shifted as their party either gained or lost ground within their state over time.

### The Decline of Party Thesis: Misinterpreting Political Change

The dominant interpretation of American political parties during the period 1960s – 1990s is that they suffered decline. Identification with parties declined, split-ticket voting increased, and presidential-House results in House districts separated. The analysis this book develops is that the 1960s saw the beginnings of a long and sustained realignment, driven by the party's desires to secure electoral bases more compatible with their evolving ideologies. Changes that were interpreted as party decline were really reflections of realignment. Realignment created voters moving away from their party as party images and positions changed. Presidential results changed faster than House results, creating an increase in split-outcomes. The book uses the announced goals of parties in memos, essays and books to discern party goals. The analysis then proceeds by tracking how goals were fulfilled in election results and how this changed party loyalties.
